



## REQUIREMENTS FOR VISITATION AT INTERCARE SITES

### ATTENTION VISITORS!

**PRIOR to entering an Intercare site, you MUST:**

1. Complete your COVID-19 SELF-SCREENING health assessment;
2. Confirm you DO NOT have any of the symptoms listed below; AND
3. Confirm (attest) your completion of #1 and #2 above by SIGNING the designated visitor sign-in sheets.  
(Sign-in sheets are located at the COVID-19 screening tables and/or reception desks)

**For the ongoing health and safety of our residents and patients, you must answer “NO” to all of the following before entering our Care Home:**

1. Are you currently sick or feeling unwell?
2. Have you tested positive for COVID-19 within the past five (5) days?
3. Have you experienced any of the following symptoms within the past five (5) days:
  - ✓ Fever?
  - ✓ Cough?
  - ✓ Shortness of breath?
  - ✓ Runny or stuffy nose?
  - ✓ Sore throat?
  - ✓ Nausea/vomiting/diarrhea?
  - ✓ Loss of taste or smell?
  - ✓ New rash?
  - ✓ Feeling unwell?
4. Have you (regardless of whether you are fully vaccinated) had a recent close contact with anyone who is COVID-19 positive requiring you to NOT visit a continuing care home for a minimum of fourteen (14) days?

**IF YOU HAVE ANSWERED “YES” TO ANY OF THE ABOVE QUESTIONS  
YOU ARE NOT PERMITTED TO ENTER THIS CARE HOME AND SHOULD DEPART THE PREMISES.**

**IF YOU HAVE ANSWERED “NO” TO ALL OF THE ABOVE QUESTIONS, YOU MAY SIGN-IN ON THE VISITOR SIGN IN SHEETS AND ENTER THE CARE HOME WHILE ENSURING YOUR COMPLIANCE WITH THE FOLLOWING:**

5. **Visitors must wear face masks at all times while on site**, in accordance with the Alberta’s Chief Medical Officer of Health (CMOH) Order 37-20-21; this includes while visiting in a hospice patient’s or resident’s room. (Additional personal protective equipment (PPE) may be required as/if directed by Intercare staff.)
6. Visitors are asked to perform **hand hygiene** when entering and exiting the site, after using a washroom and when entering or exiting the patient’s/resident’s room.
7. Visitors are asked to keep **physically distant** from anyone who is not from within their own household while at the site, where ever possible.

**POINT OF EMPHASIS:** Visitation requirements may be changed without notice based on changes to visitation guidelines in continuing care issued by Alberta’s CMOH and/or as deemed necessary by Intercare for the safety and well-being of our patients, residents and staff. We apologize in advance for any inconvenience such changes in visitation may cause, when and if they occur.

Thank you for your cooperation, support and understanding as we continue to work together with our patients, residents, family members and staff, to manage visitation within our care homes.
